

Please complete and return with your 50% deposit: the trip balance is due 30 days prior to your hunt. We accept checks, cash, and credit cards. Credit cards can be taken over the phone and will be charged a 3% convenience fee.

Cancellation Policy: Deposits are non-refundable and considered partial payment towards your trip. Refunds are only allowed due to natural disasters or circumstances preventing access to hunting property. Hunting cancellations made less than 180 days prior to hunt will forfeit 1/2 of total cost of trip. Any remaining deposit may be applied to a future reservation within two years. We recommend trip insurance for your protection in the event of unforeseen circumstances. Return contract and deposits promptly to confirm your reservation. Once a deposit is paid and a Nebraska license is issued, you are responsible for the entire cost of the hunt. There are absolutely NO refunds on any payments received. NO rate reductions or extra days will be given if hunters leave before the conclusion of their hunt or fail to arrive at the scheduled dates.

AGREEMENT:

Obligations of the Outfitter: In performing the services list above, SANDHILLS OUTFITTING SERVICES, LLC promises to do the following:

- 1) 4 full days of hunting with transportation to and from stand location.
- 2) Provide professional and licensed guides for the guide to client ratio.
- 3) Use diligence and safety in all matters for the client, but it is understood that many things can effect hunting (ie. weather, your preparedness, physical condition, etc. and we do not guarantee success).
- 4) Provide proper care of trophies in the field
- 5) Pay for food, lodging, snacks, and beverages (Plan A)

Extra Services provided by SOS - Deer Hunt:

- 1) Transportation to and from North Platte Airport available for an additional \$150 per vehicle (3-4 per vehicle max)
- 2) Extra trips to North Platte with S.O.S. vehicle, \$1.00 per mile or \$50.00 minimum
- 3) Meat processing and skinning available for an additional fee of \$150 per animal
- 4) Caping of animal for shoulder mount is available for an additional fee of \$75 per animal
- 5) European mount preparation for out of state travel for an additional fee of \$25 per animal
- 6) Transportation to and from North Platte Airport available for an additional \$150 per vehicle (3-4 per vehicle max)
- 7) Extra Whitetail Doe harvest \$200 per animal & Extra Mule Deer Doe harvest \$500 per animal
- 8) Extra 2nd mule deer buck harvest \$3,500 and extra 2nd white tail buck harvest \$3,000
- 9) If hunter wants to butcher his own deer, Cost for: knives, vacuum sealer & bags, ziplock bags, will be an extra \$40 per animal. (Includes disposal of carcass)
- 10) European Mounts \$125 completed
- 11) Fall Turkey ADD on to deer hunting packages: Tom's \$1,000 - Hens \$250

Extra Services provided by SOS - Turkey Hunt:

- 1) Extra or second bird harvest (Spring Hunt) - Merriam Tom \$500, Eastern Cross \$250, Hunted but not harvested \$100
- 2) Processing of turkey w/supplies \$20 per bird

Obligations of the Client:

- 1) Transportation to and from hunt.
- 2) Storage of meat and cape.
- 3) Provide own personal clothing, equipment, and weapon.
- 4) Pay costs of all license fees, meat processing, taxidermy including shipping of hides and antlers, & any other shipping costs.
- 5) Pay for food, lodging, snacks, beverages and transportation costs for dates in this agreement (Plan B)
- 6) Obey all laws and conduct him/herself in a reasonable, prudent and safe manner under any circumstances.
- 7) Client hereby agrees and acknowledges that he or she has had ample opportunity to investigate and study the inherent dangers and risks associated with engaging in the activities and services set forth above and that SANDHILLS OUTFITTING SERVICES, LLC will not be held liable for injury or illness while on property and pertaining to adverse weather (snow, sleet, ice, wind), rugged terrain, and dangers posed by wild animals. Client expressly agrees and acknowledges that he accepts and consents to all the risks associated with any activity as part of this agreement.
- 8) Client also agrees that he or she is in the appropriate physical condition and possesses the sufficient outdoor and hunting or fishing skills to reasonably undertake the services set forth herein and to fully participate in and enjoy the same despite the inherent risks and hardships.
- 9) If while on your hunt, you are unable to hunt due to illness or you are hurt, sorry but there is no refund.

WAIVER AND RELEASE OF ALL CLAIMS AND LIABILITY

In consideration of being allowed to participate in the activities offered by SANDHILLS OUTFITTING SERVICES, LLC of which I voluntarily request the right of participation, I hereby state and acknowledge as follows,

- 1) I voluntarily request the right to participate in activities offered and understand and appreciate the risk of the activities in which I desire to participate and do acknowledge the risk of personal and/or property injury as well as death.
- 2) Even with such understanding and appreciation of the risk, I still desire to participate or have my minor children participate, and I do hereby fully and irrevocably release and forever discharge SANDHILLS OUTFITTING SERVICES, LLC, its officers, directors, employees, agents, members, and all owners and lessees of the property from any and all legal claims, demands, actions, losses, and/or legal liability of any kind of nature or description and resulting from such activities sustained by me or my minor children, and further covenant to hold all said parties harmless.

3) I do hereby personally assume all risks which may be associated with such activity. I understand and acknowledge that this is a legal and binding contract and by affixing my signature hereto acknowledge that I have read and fully understand the waivers and releases contained herein.

4) I (hunter) hereby release, discharge and promise not to sue the landowners and any other person, trust or entity with a present or future, possessory or non-possessory, legal or beneficial interest in any portion of the hunting property, and/or any of their members, managers, employees, agents, heirs, next-of-kin, spouses, successors or assigns for the loss, liability, damages or cost whatsoever arising out of or related to any loss, damage or injury (including death) to my person or property, including my children. I (hunter) hereby release the landowners and SANDHILLS OUTFITTING SERVICES, LLC from any claim that they are or may be negligent or grossly negligent in connection with any injury, loss or damage to person or property occurring on the hunting property and/or in connection with my hunting activities on or near the hunting property, including, but not limited to: provision of, maintenance of, or failure to provide or use hunting gear; maintenance of or failure to warn of roads, ditches, blinds, structures, shelters, fences, fields, ravines, crevices, holes, wells, creeks, rivers, trees or any other place or hazard on the hunting property, whether natural or man-made; failure to warn of or restrict others from hunting on or entering the hunting property; failure to provide aid or to rescue, or if aid is attempted by the landowners or SANDHILLS OUTFITTING SERVICES, LLC or by others, failure to exercise requisite care in such attempt; infliction of emotional distress; and incidents involving the discharge of firearms and the use of other weapons.

You (hunter) must agree to the following rules; failure to do so may result in the immediate cancellation of your hunt with no refund.

- 1) Hunters must not leave their immediate stand area without a guide. (This does not include walking directly to or from vehicle or drop off spot.) This DOES include tracking wounded game. SANDHILLS OUTFITTING SERVICES, LLC Representative must be present during tracking.
- 2) If a hunter shoots and misses, loses an arrow, and/or hits a deer the hunter WILL tell a representative of SANDHILLS OUTFITTING SERVICES, LLC IMMEDIATELY if a deer is hit but can't be found or an arrow is shot but can't be retrieved, the hunter will be done hunting until the hunter pays \$1000 to SANDHILLS OUTFITTING SERVICES, LLC for landowner loss of deer BEFORE being allowed to resume hunting.
- 3) Hunters may harvest any buck gross scoring of 140 inches or better. Any hunter harvesting a smaller buck than this will pay an additional \$500 fine unless approved by SANDHILLS OUTFITTING SERVICES, LLC. (This is intended to protect 2-1/2 year old and younger bucks to allow them to reach trophy proportion.)
- 4) Hunters must agree to respect other hunters, guides and landowners. Hunters must not damage, in any way, property of landowners or SANDHILLS OUTFITTING SERVICES, LLC.
- 5) Any hunter that is found to be out of their designated area will be done. They will forfeit their hunting fees, their hunt is over and they can go home. Trespassers will not be tolerated.
- 6) Hunters must wear attached safety belts at all times while in a tree stand.
- 7) SANDHILLS OUTFITTING SERVICES, LLC reserves the right to 3% of any and all earnings if you harvest a "World Record Buck".
- 8) SANDHILLS OUTFITTING SERVICES, LLC reserves the right to use any photos and names of hunters in advertising and promotion of the club.

Gratuity: – Our Cooks and Guides work hard to provide the best experience for all our guests. Please show your appreciation with a tip for both. Normal practice is \$300 or more to the guide per animal & \$25-\$50 to the cook.

To hunt you need to have these items in your possession at all times. We follow and strictly enforce the hunting regulations for the State of Nebraska.
